REFLECTIONS FROM OUR CEO

Dear Friends.

At HealthRIGHT 360, we believe healthcare is a human right, and that means more than access to a physician. It means ensuring people can receive the behavioral healthcare they need without shame; afford housing, medications, and nutritious food that meets their needs and preferences; and rely on up-to-date vaccines and trusted, scientific guidance to keep their families healthy. This year, our commitment to integrated care has taken on renewed urgency as critical pillars of public health, such as Medicaid, food assistance, vaccines, and scientific infrastructure, have come under threat.

Decisions made at the federal level are undermining the very systems that help our communities heal and thrive. These cuts jeopardize access to healthcare, particularly for marginalized populations and those historically excluded from traditional systems. They also compromise the data and research that guide local and state responses to overdose, natural disasters, and emerging medical concerns; and endanger our ability to allocate limited resources effectively across the continuum of care.

Our work has always been grounded in science, equity, and compassion, and never has that approach been more essential.

In the face of these challenges, we have expanded our integrated services, deepened our advocacy, and invested in the behavioral health workforce of the future. This includes launching a student loan repayment fellowship to retain and support early-career clinicians, growing our apprenticeship and training programs, and opening new opportunities in the field for people with lived experience. Our exceptional staff, many of whom have personal histories that mirror those of our clients, remain at the heart of our mission and the key to our success.

We are proud of what we have built together: a modernized network that delivers dignified, stigma-free care to almost 44,000 people each year. Whether we are helping a mother navigate recovery through our perinatal programs, supporting a senior reentering the community after an extended period of incarceration, offering integrated primary care to an unhoused neighbor, or bringing a smile to a child with our free dentistry, we meet people where they are and stay with them as they move toward their own goals for health and well-being.

We remain committed to making our programs safe, affirming spaces for LGBTQ+ individuals; welcoming and culturally and linguistically responsive to immigrant communities; and rooted in the belief that everyone deserves quality treatment, regardless of background or ability to pay. Our participation in the California Recovery Incentives Program continues to demonstrate meaningful progress in improving engagement and recovery for people with stimulant use disorder.

As you explore the data and stories in this year's report, I hope you will see what I do: a future that is still within reach, powered by compassion, integrity, and the belief that everyone deserves a chance to heal. And we hope you will continue to stand with us as we face what is ahead together.

ACCOMPLISHMENTS FROM 2024 – 2025

How HealthRIGHT 360 is furthering our mission to provide non-judgmental healthcare to people and communities in need.

In FY24-25, HealthRIGHT 360 (HR360) reached almost 44,000 low-income, vulnerable Californians with evidence-based interventions, including primary dental and medical care, residential and outpatient mental health and substance use disorder treatment, transitional housing, services for men and women who are re-entering the community following incarceration, and much more.

HR360 launched multiple projects to standardize treatment at our programs. Our programs across the state, and especially in San Francisco, are accomplishing high levels of performance. In March 2025, HR360 passed a rigorous accreditation process by the Commission on Accreditation of Rehabilitation Facilities (CARF) with flying colors, receiving unanimous commendation for our clinical integrity and impact.

We have improved staff retention across the agency by expanding our HR team to include recruitment staff; increasing salaries across the agency; improving our onboarding process; and building a workforce training program pipeline to prepare and hire underserved individuals for career-track mental health care roles. Our improved staff retention levels have allowed us to increase client service capacity. Our residential programs are at full capacity, with every bed filled as a result of our hiring successes.

To meet our increased need for Medication-Assisted Treatment, we have added new exam rooms in the Intake Department of our Integrated Care Center in San Francisco to expand appointment capacity. Despite ongoing challenges with healthcare worker shortages, our medical clinic secured additional permanent providers, increasing our capacity for client services.

Our agency has successfully implemented a new remote pilot program monitoring system at all our residential SUD treatment locations. The new system ensures staff are more directly monitoring clients who are at highest risk for overdose. Our work was featured in the "Wall Street Journal" in an article exploring individuals facing complex health and social challenges. We are incredibly proud of the expertise and compassion our staff bring to the field.

HR360 launched Enhanced Care Management (ECM) services in Orange County in FY23-24 and has now expanded our programming to include jail and prison in-reach services. In-reach services enable clients to enroll in Medi-Cal benefits and receive reentry case management up to 90 days before release.

We are pleased to report that we were awarded funding through the Behavioral Health Continuum Infrastructure Program (BHCIP), which is part of the first round of Proposition 1 investments administered by the California Department of Health Care Services. With this support, we will expand vital services in Santa Clara and Ventura Counties, creating 120 new residential beds for individuals experiencing substance use disorder and co-occurring mental health conditions. These projects will significantly strengthen local access to withdrawal management and residential treatment, services that are urgently needed and long overdue.





HEALTHRIGHT 360 FAMILY OF PROGRAMS

Asian American Recovery Services provides an array of culturally competent behavioral health services to the Asian, Pacific Islander, Native Hawaiian and other ethnically diverse communities of the San Francisco Bay Area. Our programs serve youth, adults, and families, and are located in San Francisco, Santa Clara, and San Mateo Counties. In 2025, AARS celebrated 40 years of serving the community and 30 years of the Sister-to-Sister Youth Leadership Conference.

Haight Ashbury Medical Clinics offers primary medical, dental, substance use disorder treatment, and mental health services guided by our historic principle that "Healthcare is a Right, Not a Privilege." Our supportive staff is experienced in addressing the complex healthcare needs that result from homelessness, poverty, and addiction. Clinic providers have specialized expertise in preventative health, chronic conditions, infectious disease, and addiction.

North County Serenity House provides a gender-responsive and trauma-informed environment, using evidence-based and best practices that recognize and account for the role that trauma frequently plays in the lives of the women and men we serve. NCSH operates residential treatment and transitional housing programs throughout San Diego County.

Prototypes is a lifeline to women who are struggling with addiction and other serious issues such as domestic violence and mental illness. Mothers with small children may enter residential treatment as a family. Prototypes operates several sites throughout Southern California, serving thousands of women, men, and children each year.

Rock Medicine provides mobile medical triage and coverage at concerts, music festivals, sporting events, parades, and other large events throughout California. For more than 50 years, Rock Med volunteers has provided free, non-judgmental care and set the standard in event medicine.

Walden House has been providing behavioral health services since 1969, serving people with mental health and substance use disorder issues at various residential and outpatient facilities throughout California, including incustody treatment programs and services for people transitioning back into their communities.

Women's Recovery Association in San Mateo County provides a comprehensive continuum of care including residential treatment, professional clinical services, and community peer support. The comprehensive programming includes individual and family counseling, group therapy, and educational groups that focus on women's recovery from substance use disorder and related addictive behaviors.




